

### The crucial role of independent schools

It is a privilege to chair the Board of Governors of the Heritage Foundation and a great pleasure to remain involved in this remarkable school which has unleashed the potential of so many girls to be achievers and leaders.

As one views the educational landscape in South Africa today, the government itself acknowledges that the country's educational system is failing to effectively equip sufficient numbers of South Africans with the skills required to become productive citizens.

A vital factor in this scenario is the provision of quality education: while independent schools form only some five percent of the school system, they deliver a disproportionate number of graduates, particularly in scarce skills such as English, Maths and Science. In this regard it is pleasing to report that in the 2010 matric results, 29% of our students received distinctions in Maths, 35% Science distinctions and 30% distinctions in English. A significant number achieved 70% or higher.

Independent schools such as St Andrew's thus have a crucial role to play.

Given that St Andrew's will be celebrating its 110th anniversary in 2012, what better way of commemorating this milestone than a donation to the Foundation? Your support provides the school with the long term financial means to, for instance, attract and retain the best teachers possible, have funds available for capital projects and offer more bursaries. Every rand that our community donates to the Heritage Foundation, be it monthly, annually or occasionally, is indeed an investment in the future of this country.

Skilled people are the key to the future. I'm very pleased therefore to say that Imperial Select has sponsored a five-year academic scholarship that has been awarded to an extremely talented girl from a disadvantaged community. Our other bursary recipient, Tiffany Holdcroft, completes her postgraduate studies this year, having received A's for all her exams. Thanks to the R1 million received from the Graham Beck Foundation, we are in a position to select another worthy candidate to receive financial assistance to study for a Maths, Science or English teaching degree in 2012. In this small way, St Andrew's is making a contribution

#### Education facts - South Africa today

- About 1.2 million children start Grade 1 every year
- Only approximately 600 000 reach matric
- Just over 100 000 (about 8%) qualify to go to university

#### St Andrew's 2010 matric results

- 74 students wrote matric. 97% qualified to go to university
- Of a total of 206 distinctions obtained, 50 were distinctions in Maths, Science and English.
- For 22 consecutive years the school has had a 100% pass rate in matric
